The Chukchansi Economic Development Authority is eagerly engaged in annual charitable donation activities that enrich the lives and vitality of our precious community. The mission of this donation program is intended to give back to our Tribal Member community by providing monetary donations that contribute toward effecting positive change and education.

### **Donation Guidelines**

As Chukchansi Economic Development Authority ("CEDA") is dedicated to give back precious resources that best meet the needs of the community, we will receive and review applications for donations under the following set of guidelines:

- Donation must be submitted in writing on a CEDA Donation Request Form.
- Must include a narrative describing the program, organization, or project and the unmet need. The Narrative should also include how this donation will benefit the Tribal family.
- Applicant must reside within the 75-mile radius of Picayune Rancheria.
- All applications must be completely filled out and submitted to:

- To allow for receipt, review, approval, and processing Donation Requests must be received no less than 45 days prior to the event.
- Requests are subject to Enrollment and Education Department verifications.
- Requests will be limited to once per calendar year and capped at \$500.00 per request.
- Tribal Member must apply through the PRCI Extracurricular prior to applying for a CEDA Tribal Member Extra-Curricular Donation Request.
